MONUMENT SET:

I accepted a mound of stone surrounding an old fence corner with downed fences South and West as best remaining evidence of original corner position. There are also rock jack remains extending East from the mound of stone. We also found a railroad spike laying flat at the fence corner. At the reestablished corner position, set a 1 1/4" x 30" galvanized iron pipe with a 2 3/8" brass cap 22" in the ground and surrounded with a mound of earth and stone. Monument marked as shown in Monument Marking Detail.

From which:

"XBO" chiseled in the top of a 3 ½' x 2 ½' x 1' rock outcrop bears North 54 1/2° East, 26.5 feet. A 5/8" x 24" iron rebar with yellow plastic cap stamped "OR PLS 1106, WA PLS 17372", bears South 49° East, 31.4 feet.

A 5/8" x 24" iron rebar with yellow plastic cap stamped "OR PLS 1106, WA PLS 17372", bears South 50° West, 48.4 feet.

A 5/8" x 24" iron rebar with yellow plastic cap stamped "OR PLS 1106, WA PLS 17372", bears North 55° West, 45.7 feet.

Attached bearing object signs to rebar accessories. Attached witness sign to railroad tie fence corner which is leaning, West of corner.
