At the reestablished corner position, there are a few old wood posts which are burned indicating a fence at one time in the past. There is no indication at this time of the direction(s) the fence may have ran. Set a 5/8" x 24" iron rebar, 20" in the ground to bedrock with a 2" aluminum cap attached. Surrounded with mound of earth and stones. Set a steel fence post with witness sign 1 foot West of monument.
