MONUMENT AND ACCESSORIES FOUND:

Found and held a 20"x11"x7" set stone (no marks) projecting 6" above ground level in mound of stone as best remaining evidence of the original corner position.

MONUMENT SET:

At position of the set stone set a 1 1/4" x 30" galvanized iron pipe with a 2 3/8" brass cap attached, 24" in the ground and surrounded with a mound of earth and stone. Cap marked as shown in Monument Marking Detail.

A 3/4" brass washer stamped "PLS 1106" 1 foot above ground level in a B.P.A. transmission line pole marked "MCNY RUUN 29-8-A" bears, North 50° East, 74.6 feet.

A 5/8" x 24" iron rebar with yellow plastic cap stamped "OR PLS 1106, WA PLS 17372", bears South 50 1/2° East, 46.4 feet.

A 5/8" x 24" iron rebar in fence line with yellow plastic cap stamped "OR PLS 1106, WA PLS 17372", bears South 63° West, 45.6 feet.

A $5/8" \times 24"$ iron rebar in fence line with yellow plastic cap stamped "OR PLS 1106, WA PLS 17372", bears North 28° West, 55.7 feet.

Attached bearing object signs to all rebar accessories and to transmission line pole with brass washer. Set steel fence post 2 feet East of brass cap monument with witness sign attached.

Corner is set located on gentle ridge top approximately 80' South of B.P.A. transmission line.
